•	Initial	_ Tuition is due on the first of the month. A late fee of \$50 is assessed if tuition is not paid by the 5 <sup>th</sup> . Returned checks are assessed a \$50 service fee.
•	Initial	Tuition is based on an annual 12-month cost of the program. Payments are divided into equal monthly payments. The amount due is unrelated to the number of school days per month.
•	lmitial	_ All enrollment and tuition fees are non-refundable.
•	Initial	A 20 day written notice of withdrawal is required to provent any future financial
•		_ A <b>30-day written notice of withdrawal</b> is required to prevent any future financial obligation. *Exception: Natural disaster or pandemic.
•	Initial	_ A <b>30-day written notice</b> is required for any changes in schedule.
•	Initial	_ I understand that the tuition prices increase once a year (in July)
•		_ I give permission for my child to participate in school-sponsored field trips and for my child to be photographed or videotaped for school purposes.
•		_ I understand that the Licensing Agency that governs this facility under the State of
•		California Department of Social Services - Child Care Division has the authority to interview children, inspect and audit their records without prior consent.

•		_ I will notify the school immediately if there is a change of address, email or phone
